





Of the \$9,548,787 in LCFF Funds, \$294,831 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



In 2022-23, El Rancho Charter School is projecting it will receive \$294,831 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2022-23]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

El Rancho Charter School serves 1100 seventh and eighth grade students in Anaheim Hills, California. The mission of El Rancho is to "Maximize Every Student's Learning and Personal Responsibility." The quality of any program begins with high expectations. This is not just what is expected of the students, but what is expected of teachers, parents, classified employees, and administrators. School personnel are well aware that it takes all of these entities to create student success both in and outside of the classroom. In addition to a very solid curriculum focusing on the Common Core State Standards, El Rancho is proud to offer an extensive elective program. Students may select from a variety of courses in the fine arts, foreign languages as well as the practical arts. They may choose percussion, orchestra, dance, an array of art, woodshop, and technology classes. In addition, El Rancho is proud to offer an exemplary physical education program which incorporates the use of science, technology, engineering, and math into daily lessons. Through collaboration of the students, staff, parents, and community, the culture and atmosphere is one of support and accomplishment.

In order to ensure all students reach their highest potential, we offer many supports and interventions to allow all students more time during the school day to reach their goals. We have multiple tiers of support which allow for all students to benefit. All students participate in the twice-a-week tutorial program. This has helped all students improve academically and allows time for them to master concepts that might have been left behind in the past. In addition, we provide after-school math academy and homework club so students can obtain help from teachers in various content areas. To support students in English and math, we offer two-period block classes with reduced class sizes, so students receive more individualized attention and have more time to learn and practice content material. Finally, for students who require intensive supports, we provide mandatory tutorial two days a week, have a check-in check-out system, offer an academic skills course, and these students have weekly meetings with their advisor.

It is the goal of El Rancho Charter School to offer academic excellence to our families by providing flexibility through our charter and a continuous model of improvement. As the result of the balance of educational supports, elective choices, a quality physical education program, and high academic results, along with social and emotional supports are the key to success.

Reflections: Successes

While EI Rancho has focused on math and English and have made some gains in each content area, we intend to maintain our commitment on improving in these two academic areas. Analyzing results in both math and English along with reviewing our interventions has allowed us to focus on the needs of all of our students. This analysis also allows us to continue our focus on particular areas of need for our students with disabilities, EL, low-income and foster youth. In addition, El Rancho has expanded our social and emotional supports of all students. El Rancho is committed to working through the Performance Index Review (PIR) process in ELA to support our special education students. El Rancho was able to bring 100% of our students back to campus using COVID protocols and contact tracing to ensure student safety and learning. Even though other testing options were available for the 2020-2021 school year, El Rancho was able maintain consistency through CAASPP testing in order to determine students outcomes. We had mixed results overall, however an area of success included maintaining a similar performance in ELA for both 7th and 8th grade students. When comparing our 2018-2019 to 2020-2021 CAASPP results, we were able to maintain our ELA percentage at 74% standards met for 7th grade, and 65% for 8th grade. Overall our ELA score is 70% proficient. In addition, science improved from 45% to 49% proficient. When comparing our 2018-2019 to 2020-2021 English Language Proficiency for Summative ELPAC, our scores increased from 24% to 44% proficient. Our Dashboard indicators in 2019 reflect an overall performance in the "Blue" performance category for both ELA and math.

Reflections: Identified Need

Based on the California Dashboard, an area of improvement going into the 2020-2021 school year was to focus on our suspension rates. During the 2020-21 school year, due to students returning from distance learning and a suspension of the Dashboard, El Rancho had very few at home suspensions. A area of need from our Dashboard indicator from the 2019-2020 school year includes the need to make progress on our suspension rates. Of the 1196 students enrolled, 2.6% were suspended which put us into the Orange performance category on the Dashboard. With all students returning for the 2021-22 school year, suspensions were again a focus.

In addition to suspensions, El Rancho focused many of our efforts on the mental health and increased needs of many of our students. This will be a continued need moving into the 2022-2023 school year, to further engage students with their learning and social and emotional needs.

When comparing our 2018-2019 to 2020-2021 CAASPP results, El Rancho did drop in our math performance from 66% to 56% in 7th grade math and from 65% to 48% standards met. Overall our math score is 52% proficient. We are focusing on filling in the unfinished learning due to COVID.

El Rancho will continue to prioritize ELA, math, and supporting the mental health needs of our students. Analyzing results in both math and English along with reviewing our interventions has allowed us to focus on the needs of all of our students. This analysis also allows us to continue our focus on particular areas of need for our students with disabilities, EL, low-income and foster youth. In addition, El Rancho has continued to see a greater need to support the social and emotional needs of all students. We have created a website with expanded resources and extended counseling to all students to ensure their well-being is taken into consideration.

Several surveys were used throughout the 2021-2022 school year in order to determine the needs of students as we transitioned back to 100% in person learning. These surveys included input from students, parents, and staff to ensure proper supports and needs were being addressed.

A summary of the feedback provided by specific educational partners.

As we have gone from 100% distance learning back to 100% in person, many teachers have continued to use the technology tools from distance learning. Of the students, staff and parents who responded to the survey, 77% said students preferred using technology as a resource. Platforms including Google Classroom, Edpuzzle, Peardeck, and Jamboard are some of the tools which continue to be utilized by teachers in their classrooms. Of those surveyed, 79% believe teachers are effectively using technology as an instructional resource. In the area of textbook and learning materials, 97% believe these materials meet the needs of all students, including English Language Learners and students with disabilities. Of those surveyed, 100% believe the math textbooks or learning materials meet the needs of all students, including English Language Learners and students with disabilities. In the area of interventions and supports, 95% believe a double math period, tutorial, math academy, and homework club are sufficient academic supports.

Based on the feedback of students, staff and parents, El Rancho will continue to use technology as a teaching tool, provide continued supports and interventions to meet the needs of all students, as well as continue to provide mental health resources and supports. Our foster youth, English learners and low-income students were considered first when we returned to in-person learning. El Rancho offered a 4 day a week option for in person learning during the 2020-21 to those struggling academically and socially. This allowed for students with access to their teachers, and support staff, on a daily basis to support their learning. As we started the 2021-2022 school year, a double math class and an additional reading class was provided to address unfinished learning. After school programs, as well as a twice a week tutorial, was implemented to support all students. Based on various academic tools including I-Ready data for ELA and math, interim assessments, and student performance, continued supports will take place during the 2022-23 school year.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

Services will be increased or improved by offering the following for the 2022-2023 school year: Read 180 and a Reading block English class, additional classroom aide support throughout the day, as well online support through extended I-Ready lessons to fill in gaps in learning. In addition, an increase in the area of technology will be used to support student learning. Additional courses with a smaller class size will continue to support students within the subgroups, as well as other students with gaps in learning. Our percentage of required improvements

for student supports will remain the same, even though we have declining enrollment. In other words the expenses remain the same, but servicing fewer students.
