High School adoptions are content area based, with teachers selecting appropriate materials for the course objectives as outlined in the course description approved by the Board of Education. Selected texts are submitted to the Board for approved use in classrooms with purchase ratio of one per student. The Public Hearing and Adoption of Resolution No. 15-21-22 of the Board of Education of Orange Unified School District on the sufficiency of textbooks, instructional materials, and science lab equipment (9-12) was approved on September 30, 2021.

2021-22 School Safety Plan

Each of the district's schools develops and adopts, in accordance with Education Code § 32280 – 32289, a Comprehensive Safe School Plan particular to their site. Each school site is required annually, by March 1st, to have reviewed, and if necessary, update their Safe School Plan. Each school forwards its Safe School Plan to the district office of School and Community Services. The office of School and Community Services provides plan development assistance to the schools and maintains a file of individual school plans available for inspection by the public.

Panorama Elementary School provides a safe and positive learning environment for all students. Maintaining the safety and functionality of Panorama Elementary is of the utmost importance. Gates are locked during the day to prevent unauthorized access to the school grounds. To maintain security, visitors to our school are required to enter through the office and check in for identification purposes.

Teachers are trained in district procedures regarding student safety. Classroom doors are kept locked during the day, and each room is equipped with a "Lock Blok" device in order to allow for the doors to be kept slightly open, but still locked. A comprehensive safety and disaster plan is in effect and fire and/or earthquake drills are conducted monthly. Campus lockdown drills are also conducted throughout the year. The office of School and Community Services participates in the planning of such drills to help each school prepare for worst-case scenarios. Panorama's PTA purchased equipment and supplies for every classroom for emergency use, as well as supplies for the entire school to use in the case of a disaster.

Each classroom is equipped with a two-way radio to enhance communication in an emergency situation. Panorama uses School Messenger to schedule, send, and track personalized voice messages to the school community for outreach and emergency purposes. In addition, all schools in the district are linked through an emergency radio contact system and district radio drills are held periodically for preparation in case of emergency. We strive to create and maintain active partnerships with our local Fire Authority, Orange County Sheriff Department, and California Highway Patrol. The staff and community work together to maintain a safe campus.

Professional Development

This year's site-level professional development will focus on social-emotional learning, using i-Ready data to guide instructional decisions, data chats, and inquiry. In collaboration with the Instructional Leadership Team, we identified the previous areas to align with our vision and mission statements. Our professional development is conducted in August before school starts and on Wednesdays throughout the school year. Modified Wednesdays allow all grade levels at Panorama to meet weekly as a full staff and in Professional Learning Communities. In addition, all staff meets twice a month for professional development training and staff meetings.

For the last two years, the district has focused on technology professional development due to distance learning. This year, staff participated in Tech Quest professional development, as well as received training on cybersecurity. We will continue to incorporate technology for progress monitoring, differentiation, engagement, and lesson presentation. The teachers and students will use technology best practices to enhance learning and achievement, and we will continually address appropriate technology usage through our professional learning opportunities.

Educators new to the profession are supported by Orange Unified's induction Program as well as on-site teacher mentoring, staff meetings, conferences, and school-based in-service meetings. Master Teachers, who support student teachers from various local universities, have received specific training in Common Core implementation and coaching.
