What is ELOP?

Expanded Learning Opportunities Program is **before** school, **after** school, **summer**, or **intersession** learning programs that focus on developing the academic, social, emotional, and physical needs and interests of **English Learner**, **foster youth** or **low-income** pupils through hands-on, engaging learning experiences. It is the intent of the Legislature that expanded learning programs are **pupil-centered**, results driven, include community partners, and complement, but do not replicate, learning activities in the regular school day and school year.



Per unduplicated pupil projected allocation= \$ 1,250

Total unduplicated pupil enrollment= 6,380

Total projected entitlement= *\$11,683,502



*Estimate by School Services of California (7-14-22) still subject to change

ELOP Requirements


- Serve 50% of our unduplicated pupils in 22-23 school year; offer to ALL unduplicated pupils in 23-24.
- ELOP Program Plan must contain these specific elements:
 - Safe and supportive environment
 - Active and engaged learning
 - Skill building (21st century skills)
 - Youth Voice and Leadership
 - Healthy Choices and Behaviors
 - Diversity, Access and Equity
- Offer a total of nine hours per day of programming during school year (includes 6 hour school day)
- Offer 30 days of summer/intersession programming of nine hours per day
- Ensure small student to staff ratio: TK/K 10:1 and 1st-6th 20:1
- Provide a USDA approved snack
- **Priority enrollment must be given to unduplicated TK-6 students**





How Will OUSD Offer Nine Hours of ELOP?

School Year	Summer/Intersession
<p><u>Example 1:</u> Before School program (7:00-8:00) = 1 hour School day program (8:00-2:00) = 6 hours After School program (3:00-5:00) = 2 hours</p>	<p><u>Example 1:</u> Before School ELO program (7:00-8:00) = 1 hour Summer School (8:00-12:00) = 4 hours School ELO program (12:00-4:00) = 4 hours</p>
<p><u>Example 2:</u> School day program (8:00-2:00) = 6 hours After School program (3:00-6:00) = 3 hours</p>	<p><u>Example 2:</u> Before School program (7:00-8:00) = 1 hour School ELO program (8:00-4:00) = 8 hours</p>

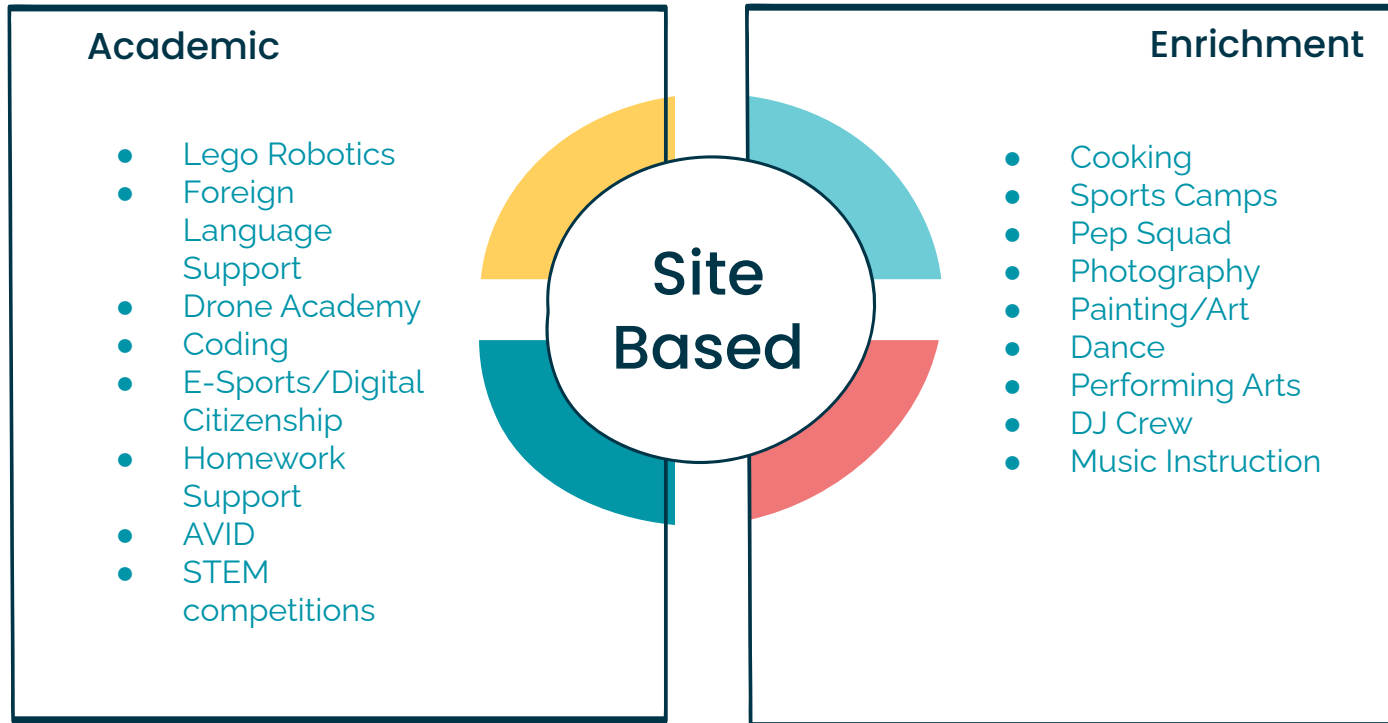

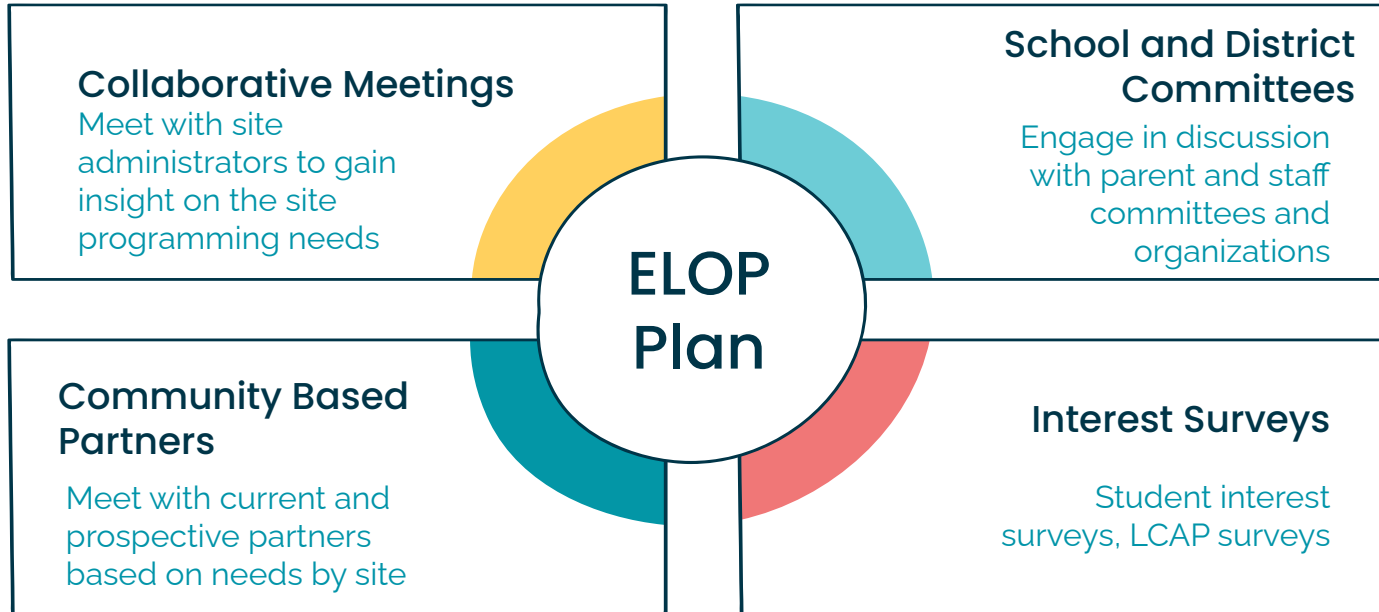
