# What is LCAP?



LCAP is the acronym for Local Control and Accountability Plan which is a tool for districts to communicate our goals, plan actions and leverage resources that will improve student outcomes and address any performance gaps. Especially for our English Learners, low income and foster youth students for whom we receive supplemental dollars for.

Annually we publish our LCAP survey that gathers input from a wide variety of our engaged educational partners: parents and caregivers, staff and students to inform our actions, programs and services in our LCAP.

# **LCAP Process and Timeline**

#### **Communication throughout LCAP process**

- Ongoing educational partners meetings at district level
- Site leaders sharing LCAP survey results with their community
- Site and district leaders holding focus groups
- Share LCAP draft highlights with DAC/DELAC in April/May
- Consultation with Bargaining Units on May 9th and May 12th

#### Timeline for LCAP approval:

- May 9-submit LCAP to OCDE for review
- May 19-LCAP Public Hearing
- June 2-LCAP and Budget for Board approval

#### Focus Area 1:

- Staff: Intervention support, mental health counselors, enrichment

#### Focus Area 2:

- Parents: communication w/home, parent workshops, community partnerships
- Students: communication w/home, parent workshops, community partnerships
- Staff: communication w/home, community partnerships, parent workshops

#### Focus Area 3:


- Parents: student wellness, anti-bullying, safety protocols
- Students: student wellness, anti-bullying, discipline policies
- Staff: student wellness, discipline policies, attendance policies

#### Focus Area 4:

- Parents: access to technology, facility improvements, cleanliness
- Students: access to technology, cleanliness, facility improvements
- Staff: facility improvements, access to technology, cleanliness

# **LCAP Focus Group participation**

- 65 focus groups including site and district
- Site focus groups varied between parents and students
- All district committees conducted a focus group
- Results from all focus groups were disaggregated by Strategic Focus Areas
- Results were divided by actions going well and actions needing improvement

# **Comparison of Survey and Focus Groups**

The following were identified as <u>priorities</u> on both the survey and in focus group data:

- Enrichment
- Social emotional/mental health support
- School/Home Communication
- Safe environment
- Facilities upgrades



# Enhancements to LCAP 2021-2024 (Year Two)

- Shift of action costs from supplemental to general fund or lottery-due to the fact actions are no longer supplemental in nature and are now considered a basic function for OUSD
- Increase of funds needed for intervention supports through Student and Community Services
- A new LCAP metric for interdistrict transfers in and out of our district
- Increase funding to support ELPAC testing
- Overall decrease in LCFF Supplemental allocation due to decline in enrollment and decrease of students identified as EL, LI and FY. (\$655K)
