The total budgeted attendance of 27,431.95 (not including District charter schools) reflects a net decrease of 488.66 ADA in general, special and adult education as compared to 2005-2006. District charter schools' ADA of 2074.18 reflects zero change as compared to the prior year.

Revenues: Although the State of California has not adopted its 2006-2007 budget at this time, a 5.92% cost of living adjustment (COLA) is included; along with \$62 of equalization and a complete restoration of the revenue limit deficit by .892%. The COLA, equalization and elimination of the revenue limit deficit yields an estimated amount of \$416 per student in the revenue limit calculation.

State categoricals are projected at 2005-2006 allocations with 5.92% COLA for those entitlements and grants known to be ongoing.

A 1% decline in anticipated for federal programs in this adoption, as the federal government adopts its budget for an October 1 fiscal year. Interest earnings are projected at 3.75% and lottery is estimated at \$148 per student (\$123, unrestricted, \$25 restricted by Proposition 20).

AB825 Block Grant transfers out include 15% of school and library improvement block allocated as follows: approximately 64% to educational technology and 46% to home-to-school transportation for both the 2005-2006 and 2006-2007 years.

Unexpended 2005-2006 grant monies are required to become deferred revenue at the close of the fiscal year and will thus reflect less income and expenditures in the 2005-2006 unaudited actuals to be presented in September. This deferred (unexpended) revenue and remaining expenditure capability will then be reallocated from the 2005-2006 actuals to the 2006-2007 budget revenue and expenditure lines when the unaudited actuals and 2006-2007 budget revisions are presented prior to September 15 as required by the Education Code.

Revenue for unexpended 2005-2006 categorical entitlements is required to be stated in the ending fund balance for 2005-2006, even though the expenditures have not occurred in the 2005-2006 fiscal year. The estimated unexpended entitlements have been included in components of the 2005-2006 ending fund balance and added to the 2006-2007 budget expenditure lines. The estimated unexpended entitlements include Medi-Cal billing program, English Language Acquisition, School Safety, CAHSEE, EIA, State Instructional Materials, Williams Instructional Materials, Peer Assistance Review, Staff Development, AB75 Principals' Training, Pupil Retention Block, Teacher Credentialing Block, CASA donations amount to approximately \$2.58 million.

Other unexpended/remaining components of the 2005-2006 ending fund balance are El Rancho Charter School, Site Performance Awards, school site discretionary budget carryovers, site/department donations, non-resident tuition and funds reserved for negotiations amounting to approximately \$2.23 million, these estimated unexpended items have been included in the 2006-2007 budget expenditure lines.

Certificated Staffing: Certificated staffing is based upon a ratio of 19:1 for grades 1-3; 30:1 for K and grades 4-6; 32:1 for grades 7-12, and 20:1 for grade 9 English and math. Salaries include step/column increases for certificated employees and step/range increases for classified employees as well as approved reorganizations. Statutory benefits (STRS, PERS, Workers' Compensation, etc.) are driven by payroll costs. Health benefits include existing 2005-2006 allocations.

OUSD/Archibald/Sorrera/Stephens Board Agenda June 22, 2006 **Expenditures:** Supplies, services/operating expenses, and capital outlay are in conformity with estimated site and program budgets. The following programs continue in the 2006-2007 budget: 1) K-3 class size reduction; 2) 9th grade class size reduction; 3) athletic program; and 4) grades 5-6 instrumental music program. Elementary vocal music for grades 5 and 6 is reinstated for 2006-2007.

Ending Balance: The projected ending balance of \$15,089,588 is comprised of the following:

The ending balance meets the state-required three-percent reserve, and the 2006-2007 budget complies with the AB1200 accountability guidelines as set forth by the State of California. Unaudited actuals for 2005-2006 and budget revisions for 2006-2007 which result from carryover and the actual adoption of the State of California budget will be presented to the Board of Education at its September 14, 2006 meeting. The First Interim Report will occur on December 7, 2006, with the Second Interim to be presented at the first meeting in March 2007.

FISCAL IMPACT:

The fiscal impact to the various funds is shown in the state budget documents. See attached Revenues, Expenditure and Changes in Fund Balance for Fiscal Year 2006-07 with Two-Year Projection.

TOPIC: PROPOSED REVISION TO BOARD POLICY 1113 – DISTRICT

AND SCHOOL WEB SITES

DESCRIPTION: Board Policies and Administrative Regulations are routinely

reviewed and updated when changes in law occur or when a specific need arises. The Superintendent is charged with the continuous and orderly review of existing policies and regulations, as well as the development of new policies when

appropriate.

The following Board Policy revision was presented for a first reading at the June 8, 2006 meeting. It is presented tonight for a second reading: BP1113 – District and School Web Sites.

FISCAL IMPACT: This item has no fiscal impact.

RECOMMENDATION: It is recommended that the Board of Education receive Board

Policy 1113 - District and School Web Sites - for a second and

final reading.

Community Relations

District and School Web Sites

To enhance communication with students, parents/guardians, staff, community members and the public at large, the Board of Education encourages the development and ongoing maintenance of District and school web sites on the Internet. Web sites shall support the educational vision of the District and shall be consistent with the District's plans for communications and media relations.

The Superintendent or designee shall develop guidelines regarding the content of District and school web sites which shall include standards for the ethical and responsible use of information and technology. These guidelines shall be consistent with law, Board policy and administrative regulation.

District and school web sites shall not include content which is obscene, libelous or slanderous, or which creates a clear and present danger of inciting students to commit unlawful acts on school premises, violate school rules or substantially disrupt the school's orderly operation.

Any links to external sites shall follow the same guidelines applicable to District and school web sites.

The Superintendent or designee shall ensure that copyright laws are not violated in the use of material on District or school web sites.

The Superintendent or designee shall ensure that web site content protects the privacy rights of students, parents/guardians, staff, Board members and other individuals.

Pictures of students, student first name, student projects, student activities and student work shall not appear on OUSD or school web pages without written parent permission.

Photographs of students shall be used only with written permission from the students' parents/guardians.

No student or parents/legal guardian telephone numbers, home or e-mail addresses shall be published on a District or school web page. Student directory information shall not be published if parents/legal guardian requests that it be withheld.

Students in grades 9-12 may have their individual and group photographs, first and last name, and statistical information such as batting average, height and weight posted on District and school web sites unless parents/legal guardian have requested this information not be posted.

Provided that parents/legal guardian has given written permission, students in grades K-8 may have their school work, individual and group photographs and their FIRST NAME only posted on the District and school web site.

Home addresses or telephone numbers of staff members shall not be posted *on District or school web sites*.

District and school web sites shall not post the home address or telephone number of any elected or appointed official without the prior written permission of that individual. (Government Code 6254.21)

No public safety officer shall be required as a condition of employment to consent to the use on the Internet of his/her photograph or identity as a public safety officer for any purpose if that officer reasonably believes that the disclosure may result in a threat, harassment, intimidation or harm to the officer or his/her family. (Government Code 3307.5)

The Superintendent or designee may establish standards for the design of District and school web sites in order to maintain a consistent identity, professional appearance and ease of use.

Staff and students may submit materials for web site publication to the District or school webmaster who shall ensure that the content adheres to District guidelines and policies.

SCHOOL CONSTRUCTION COMPLIANCE, LLP (SCC)

The District desires to apply to the State Allocation Board (SAB) for modernization funding for the asphalt paving of approximately 60,000 square feet for the parking lot, service road and athletic field swale areas and the new shade structure and photovoltaic system at El Rancho Charter School Facility. A condition of receiving the funding is that the District has a Department of Industrial Relations (DIR) approved Labor Compliance Plan (LCP). The District has submitted and received approval on its plan. A condition of the plan approval is the monitoring and interviewing of contractor's employees on the various job sites to assure that they are being paid the appropriate prevailing wage rates and benefits for the classifications of work being performed.

SCC is a division of David Taussig & Associates, Inc., and was formed to assist districts in complying with the requirements of Assembly Bill 1506, which requires the LCP as a condition of funding. SCC is uniquely qualified to provide the development and implementation of LCP's because of their familiarity with school financing, planning, and construction issues, their ability to manage large volumes of data, and the fact that SCC has no conflicts of interest with contractors and subcontractors.

ORANGE UNIFIED SCHOOL DISTRICT State and Federal Consolidated Categorical Aid Programs

ABSTRACTS 2006-2007

Title I

The Title I Program provides funds to school districts and private schools to help close the achievement gap between high and low poverty schools by targeting additional resources based on numbers of poor school-age children.

Provisions promote extending learning time in accelerated rather than remedial classes; expanding eligibility for schools to operate school-wide programs that serve all children in high-poverty schools; helping achieve effective transitions from preschool to school and from school to work; establishing accountability based on results, greatly reducing testing, providing staff development to train high quality teachers; and increasing effective parental participation, assuring fair and equitable participation of non-public school students. Title I services will be offered at the following schools: California, Cambridge, Esplanade, Fairhaven, Handy, Jordan, Lampson, Palmyra, Prospect, Sycamore, Taft, West Orange, Portola, Yorba, Orange High, and to eligible non-public school students.

Allocations are based on the number of students receiving free and reduced lunch and the most recent CALWORKS report.

<u>Title II, Part A</u> (Teacher Quality) and <u>Title II Part D</u> (Technology Education)

The Title II Program (formerly Eisenhower and Federal Class Size Reduction) provides grants to LEAs to: 1) increase student academic achievement through strategies such as improving teacher and principal quality, increasing the number of highly qualified teachers in the classrooms and highly qualified principals in the schools; and 2) holds LEAs and schools accountable for improvement in student academic achievement.

Allocations are based on CBEDS enrollment and Title I funding.

Title III

The Title III Program is a source of federal funding to be used for improving instruction for all English Learners enrolled in the district. It is part of the President's legislation "No Child Left Behind".

Allocations are based on the number of identified English Learners.

<u>Title IV, Part A</u> (Drug-Free Schools and Communities Program (DFSC))

Title IV, Part A provides funding to develop improvement and evaluate comprehensive drug/alcohol, tobacco, and violence prevention programs and activities which are consistent with the principles of effectiveness and that are coordinated with school and community-based program services. The goal of this program is to foster a safe and drug-free learning environment that supports academic achievement.

Tobacco-Use Prevention Education Program (TUPE)

The TUPE Program provides a comprehensive system of services to reduce the use of tobacco products by youth by helping them make healthful decisions through instruction and knowledge building.

Allocation based on CBEDS enrollment in grades 4-8.

Title V, Innovative Education Strategies

The Title V Program (formerly Title VI) is designed to support local education programs that are consistent with statewide education reform efforts and to provide for innovation and educational improvement to meet the needs of all students including special needs of at-risk students.

Formula allocation based on CBEDS enrollment and CALWORKS ranking.

Economic Impact Aid (EIA)

The EIA/LEP Program provides state supplementary funding to support the development of English language fluency and academic achievement of 6,730 limited English students district wide. The funding also provides for state mandated initial identification and placement testing of English Language Learners, as well as redesignation activities. In addition, staff development is provided for teachers working with students acquiring English.

Richland Continuation High School also receives a portion of the EIA funding for a State Compensatory Education Program (EIA/SCE) for their educationally disadvantaged students. The program requirements and services are comparable to the federal Title I Program.

Allocations are based on the number of identified English Learners.

Peer Assistance and Review (PAR) Program

2006-2007 CARL D.PERKINS VOCATIONAL AND APPLIED TECHNOLOGY EDUCATION ACT OF 1998, P.L. 105-332 (PERKINS III)

DESCRIPTION:

Staff is seeking authorization to submit the annual application for funding through the Carl D. Perkins Vocational and Applied Technology Education Act of 1998, for the 2006/07 school year. Funds will be expended to meet the following requirements:

- Provide a coherent sequence of courses to ensure learning in the core academic, and vocational and technical subjects.
- Provide students with strong experience in and understanding of all aspects of an industry.
- Develop, improve or expand the use of technology.
- Provide professional development programs to teachers, counselors and administrators.
- Evaluate and assess how the needs of special populations are being met.
- Improve, expand and modernize programs.
- Provide services of sufficient size, scope and quality to be effective.
- Link secondary and post-secondary vocational and technical education.

\$199,576 categorical income No general funds will be used.

The IMAC committee is composed of parents, principals, media specialists, and teachers whose responsibility is to recommend to the Board of Education approval of the considered texts.

It is at this juncture that the Board of Education places the texts and/or supplementary texts on "30-day review period," so members from the public may have an opportunity to review those texts, pending formal adoption. The texts are available for review in the Board Room this evening and after tonight in the offices of the Library Media Technology/G.A.T.E. Coordinator located in the Instructional Media Center. After the 30-day review period, the Board of Education takes formal action to adopt the textbooks and/or supplementary texts.

FISCAL IMPACT:

Textbooks will be purchased from the textbook accounts during the 2006/2007 school year. Auxiliary adoption texts are used to supplement the basic textbook and are purchased with funds other than the state textbook monies.

COURSE APPROVALS: ARTS OF THE THEATER, AUTOMOTIVE PERFORMANCE AND CUSTOMIZATION I, ENGLISH 9, ENTREPRENEURSHIP I, FRESHMAN SEMINAR, INTERNATIONAL BUSINESS, INTERNATIONAL MARKETING, SPANISH I, SPORTS MEDICINE I

DESCRIPTION:

The new and revised course outlines described below have been reviewed by the District's Curriculum Council and are recommended to the Board of Education for approval.

NEW COURSES

- Freshman Seminar is designed to promote academic success among freshmen through academic accountability, personal/social education, and career/life skills. This course will provide the opportunity for students to receive additional instruction in core areas to ensure their sustained cross-curricular success, learn about their options in higher education, and discover career opportunities.
- International Business is an ROP course that provides an introduction and overview of international business with a global perspective on international trade.
- International Marketing is an ROP course providing an introduction to marketing and an overview of the culture of international marketing with a global perspective on international trade.
- **Sports Medicine I** is a competency-based ROP course that prepares students for entry-level positions in the sports medicine industry, including an introduction to the care, prevention, and rehabilitation of athletic injuries.

REVISED COURSES

• Arts of the Theater is an innovative, advanced program especially designed for students interested in seriously pursuing performing arts as a career choice. This course will provide advanced preparation for post-secondary education and/or entry into the world of work. Arts of the Theater will give students the ability to expand their school day from six periods to a seventh period, with mini courses also offered in the evenings and on Saturdays taught by faculty and/or professionals in the field.

- Automotive Performance and Customization I is an ROP course that will explore the application of aftermarket automotive components. Modifications of interior, exterior, drive train and other components will be addressed. Theory and hands-on applications are addressed through student projects that incorporate fabrication, utilization of aftermarket products and other specialized automotive marketing concepts.
- English 9 presents the student with a literature-based curriculum that integrates the skills of reading, writing, speaking and listening through an introduction to and analysis of literary forms. The course encompasses basic reading skills through its emphasis on the genres of literature: short story, poetry, nonfiction, drama, and novel. Students will be introduced to basic research skills and the writing process. Speaking and listening will be emphasized through cooperative learning activities, critical thinking simulation, and specific units on technology will be implemented through reading, writing, speaking and listening.
- Entrepreneurship I is an ROP course that provides students with the information needed to start a business operation. Students will learn how to identify a business opportunity, understand business legal structures, small business budgeting, record keeping methods, staffing, marketing and promotion, writing a business plan, marketing plan, and technology plan.
- Spanish I is designed to help students develop the language skills of listening, speaking, reading, and writing through the study of basic elements of the sound system of the language, the basic language patterns, and the vocabulary. Emphasis will be placed upon the listening and speaking activities. Reading and writing activities will be introduced simultaneously. Cultural topics will also be presented.

FISCAL IMPACT:

This item has no fiscal impact on the general fund.

RECOMMENDATION:

It is recommended that the Board of Education approve the above-described courses presented by the District's Curriculum Council for use in the Orange Unified School District.
