REPORT OF CLOSED SESSION DECISIONS AS REQUIRED BY THE BROWN ACT

Dr. Godley reported that there was no action taken in closed session.

ANNOUNCEMENTS & ACKNOWLEDGMENTS

Dr. Godley announced that the LT-O! (Leadership Team Orange), had announced the recipients of the Administrator of the Year award for the 2005-2006 school year. Dr. Godley offered congratulations to the following three recipients: Classified Leadership: Mrs. Victoria Webber; Certificated Leadership: Mr. Frank Boehler and Elementary Leadership; Mrs. Bobbie Lansman. The awards presentation will be in May, 2006.

Mrs. Nichols mentioned a report from the District Attorney's office with regard to a case and Brown Act Violations. This report was an information report providing information about a particular case and the outcome of that case so that all municipalities could take advantage of the case law.

In addition, Mrs. Nichols wished to determine if the SACBE representatives wanted to continue having pre-board meeting meetings to go over Board agendas.

Mrs. Nichols invited Pam McDonald to address the Board and present a certificate to Erika Mullen of Canyon Rim Elementary who won the California Association of School Transportation Officials *School Bus Safety Poster Contest*. Erika will receive a check for \$50.00 from CASTO.

Mr. Ortega thanked Karen Hanson, Coordinator, Health Services, for assisting him in providing information to him on Health Services and Nutrition. Due to her assistance, Mr. Ortega has been selected to serve on the California Health Leadership Program on Obesity.

Adam Gentry, substitute SACBE representative from El Modena High School, presented the State of the School Report on behalf of Emily Haase. The report highlighted academics. El Modena's API scores rose from 733 to 757 which is the third largest increase in OUSD. Students are adjusting well to new dress code and dance conduct policies. Several teachers who joined El Modena for the 2005-06 school year were introduced during the presentation. Fall athletics were reviewed as was the progress of the winter sports.
