REPORT OF CLOSED SESSION DECISIONS AS REQUIRED BY THE BROWN ACT

Dr. Godley reported that the Board of Education took action in closed session to suspend a classified employee without pay for five days.

ANNOUNCEMENTS & ACKNOWLEDGMENTS

Dr. Godley introduced Mr. Ed Kissee, assistant superintendent, human resources. Mr. Kissee invited Miss Lauren Karg to the podium, while reading descriptive information on the requirements for becoming a National Board Certified Teacher. Mrs. Nichols congratulated Miss Karg on receiving her National Board for Professional Teaching Standards Certification and presented her with a certificate on behalf of the Board of Education and Superintendent.

Mrs. Nichols read two letters praising District employees. The first recognized Mr. Frank Boehler, director of child welfare and attendance and the second, Mrs. Mary Heller, teacher at Canyon Rim Elementary. Mrs. Nichols also provided an update of fall sports for all high schools.

Erin Hong, SACBE representative from Canyon High School, presented her second State of the School Report. Erin reported on academics, including the Stellar Technology Open House, the School Wide SEEI Assessment, the 2005 SAT scores, the Top of the Tribe Ceremony and the Canyon Reads Program. Erin's report on activities included the Annual Second Harvest Food Drive, the Winter Formal and Winter Pep Rally, Performing Arts Winter One Acts, and the first outdoor pep rally. Erin reported on the 2005 fall sports statistics, the 2005-06 winter sports and The Tribe.

The Board approved the minutes of the December 8, 2005 regular Board meeting as presented.
