Mrs. Moffat recognized Villa Park High School basketball teams for their CIF achievements and for both coaches (boys and girls teams) being named Orange County Registers Coaches of the Year.

Mrs. Moffat congratulated all of our schools that applied for Distinguished School Status. Nominees for statewide recognition for California Distinguished School are Running Springs Elementary and McPherson Magnet School. La Veta Elementary received an honorable mention.
