Board Meeting

REPORT OF CLOSED SESSION DECISIONS AS REQUIRED BY THE BROWN ACT

Dr. Godley reported that the Board of Education authorized the superintendent or designee to give notice of non re-election to a temporary provisional employee pursuant to Educational Code Section 44954(b) for the next succeeding school year.

ANNOUNCEMENTS & ACKNOWLEDGMENTS

Dr. Godley reported on the OUSD Strategic Planning Workshop which was held May 22 and May 23, 2006. There were approximately 110 participants, including students, teachers, classified staff, administrators, community members, business members, post-secondary education leaders and some elected officials. The purpose of the workshop was to chart a course for our District for the next three years. Recommendations were made for implementing a strategic plan.

The minutes from the April 20, 2006 and May 4, 2006 Regular Board meetings were approved.

- The Board of Education approved Resolution No. 50-05-06 to establish the Futuris Public Entity Trust in compliance with Governmental Accounting Standards Board Statements Nos. 43 and 45.
- The Board of Education held a public hearing regarding the instructional materials petition request to the California Board of Education for McPherson Magnet School and authorized staff to submit the OUSD petition request to the California State Board of Education.
- The Board of Education approved the option as listed for students as required by the court's ruling. Students will be required to pass the California High School Exit Exam.
- The Board of Education received the Orange Unified Education Association's proposal for 2006-2007 reopener contract negotiations.
- The Board of Education held a public hearing to receive input on the District's initial proposal to the Orange Unified Education Association for 2006-2007.
- The Board of Education postponed discussion of Board Policy revisions for the 4000 series. This item will be placed on the Board agenda for approval at a future meeting.

- The Board of Education postponed receiving the informational report from staff English Learners: Successful Strategies. This will be placed on the Board agenda for presentation at a future Board meeting.
