Board Meeting

REPORT OF CLOSED SESSION DECISIONS AS REQUIRED BY THE BROWN ACT

Dr. Godley reported that the Board of Education authorized the appointment of Mr. Ed Howard as Acting Principal at Villa Park High School after receiving the resignation of Dr. David Steinle. The motion was made by Wes Poutsma, seconded by Lissa Smith, and passed on a 4-3 vote with Board members Ortega, Ledesma and Rocco absent.

ANNOUNCEMENTS & ACKNOWLEDGMENTS

Dr. Godley began the meeting by announcing the recent passing of long-time employee Melinda Martin, who lost her battle to cancer. Melinda was employed with OUSD for over 14 years and was selected by her colleagues in 2006 as one of the Classified Employees of the Year. Dr. Godley also announced the passing of William "Bill" Frantz, who passed away at the age of 86. Mr. Franz was the Athletic Director at Orange High School from 1950 to 1958 and an active community member. Both of these fine people will be greatly missed. A moment of silence was taken in their honor.

Mr. Rocco recognized Denise Bittel for being honored as one of the state legislatures' women of the year.

Mrs. Nichols recognized Canyon Rim Elementary School and Principal Randi Leach for hosting Lowell Joint Union School District and providing them with insight into the District's programs and teaching strategies.

Hillary Christiansen, SACBE Representative from El Modena High School gave her state of the school report. Hillary provided information on Spirit Week, athletics, academics and social activities.
