Board Meeting

REPORT OF CLOSED SESSION DECISIONS AS REQUIRED BY THE BROWN ACT

Dr. Godley reported that the Board of Education authorized the Superintendent to give notice of non-reelection to an intern employee pursuant to Education Code § 44929.21(b) and to certain temporary employees pursuant to Education Code §44954(b) for the next succeeding school year. Secondly, the Board of Education is pleased to announce the following appointments: Dr. Greg Bowden as Senior High School Principal, Canyon High School on a 6-0-1 vote with Mr. Rocco absent. Mr. John Briquelet as Senior High School Principal, El Modena High School on a vote of 6-0-1 vote with Mr. Rocco absent. Mr. Ed Howard as Senior High School Principal, Villa Park High School on a 5-1-1 vote with Mr. Rocco absent. Dr. Godley also announced the appointment of Mrs. Anne Truex as Administrative Director, Special Programs on a vote of 6-0-1 with Mr. Rocco absent.

ANNOUNCEMENTS & ACKNOWLEDGMENTS

Dr. Godley announced that Mr. Harold Kibby, OUSD's first Superintendent and Orange High School's first principal passed away on April 9th. Mr. Kibby was born on April 22, 1915 and would have been 92. Mr. Kibby's educational career began in 1938 at Orange Union High School. He became Vice Principal in 1941. After serving in the Navy from 1943-1946, Mr. Kibby returned to teach at Orange Union High School. On July 1, 1947, Mr. Kibby became Orange High School's first principal at the new campus. Mr. Kibby served as the first Superintendent of the newly unified Orange Unified School District from July 1, 1953 through July 31, 1972 – 19 years. He served the students of Orange Unified with dignity and honor, but most of all, strength and compassion. The family has requested his services to be family only. In lieu of flowers, donations should be made to the Orange Rotary Club for a fund to support teacher scholarships in his name at the District. A moment of silence was observed in honor of Harold Kibby.

Dr. Godley also asked that the students, families and friends of the victims of the Virginia Tech be remembered as well during the moment of silence.

Dr. Godley announced that 3 out of the 5 schools that OUSD had applied for Quality Education Investment Act Funds have been selected through a random drawing process. Portola Middle School, Fairhaven Elementary and Esplanade Elementary will all receiving funding.

Dr. Godley announced that Canyon High School has been named a **California Distinguished School** and offered his congratulations to Principal, Gloria Duncan and the entire staff and student body for this wonderful achievement. The School will be officially honored by the Board of Education at the Board meeting of May 10, 2007.

Dr. Godley also announced that Annie Rice, SACBE representative from Villa Park High School has been accepted to USC. Congratulations Annie!

Mrs. Smith recognized the **El Rancho Charter School Science Olympiad team**, which took first place this past weekend during the State championships, which were held at Long Beach State. The team will head to Wichita Kansas next month to compete in the National Competition. Congratulations to the students and coaches!

Mrs. Nichols announced the Community Foundation of Orange is hosting the Foundation Games at Fred Kelley Stadium on April 28th. Additionally, there were four students from Orange High School who were recognized for their quick action in saving property and assisting the Fire Department. Mrs. Nichols also commended Mr. Brent McKee, Ms. Christine Hale, Mr. Jim Veit and Ms. Christine Vasquez for their assistance and participation in selecting candidates for the American Legion Boy's State.

Jeffrey Tse, SACBE Representative from Canyon High School gave his state of the school report. Jeffrey touched on the reasons the Canyon was selected as a Distinguished School as well as student achievement, student activities and athletics.

The Board of Education officially proclaimed April 23-27, 2007 as *Administrative Professionals Week* and April 25, 2007 as *Administrative Professionals Day* for the Orange Unified School District.

The Board of Education adopted a Proclamation declaring May 9, 2007 as "California Day of the Teacher" in the Orange Unified School District.
