REPORT OF CLOSED SESSION DECISIONS AS REQUIRED BY THE BROWN ACT

Dr. Godley reported that the Board of Education authorized the following: 1) Superintendent or designee to give notice of non-reelection to a temporary employee pursuant to Education Code §44954(b) for the next succeeding school year; 2) the release of a certificated administrator effective June 30, 2007; and 3) the suspension of a classified employee for five days without pay.

The Board of Education is pleased to announce the appointment of Jeanne Bentley to the position of Middle School Principal; Lydia Roach, to the position of Elementary Principal; and, Jennifer Harrison to the position of Senior High School Assistant Principal.

Dr. Godley announced that Mr. Joseph Svoboda, Math teacher from Canyon High School was awarded a 2007 Education Foundation of Orange County Schools grant for his project "Hand-Held Geometry". Mr. Svoboda will be honored at an event hosted by the Education Foundation of Orange County Schools on May 23rd.

Dr. Godley also announced that West Orange Elementary School third-grade students received \$6,000 from Wal-Mart for gathering 614 65-gallon bags full of recycled grocery bags. Beating out schools from other counties, including Orange, San Luis Obispo, Ventura and Santa Barbara – six of the students will be able to go to Washington, D.C. in June for a four-day trip. There they will accept an award from the Department of the Interior.

Mrs. Smith recognized and congratulated the Musical Theatre Department of El Rancho Charter School. The team was invited to go to Sacramento for California Youth Day in Theatre Arts and were recognized for their exceptional abilities.

Mrs. Moffat recognized Daniel Herrador of Villa Park High School as one of the \$10,000 finalists in the Irvine Company Scholarship Awards. Mrs. Moffat also recognized all eight OUSD high school participants.

Mrs. Moffat discussed attending Prospect open house with Mr. Ledesma and recognized the modernization achievements at the school.

Mrs. Nichols acknowledged the Community Foundation of Orange for hosting the *Foundation Games* on Saturday, April 28th. Mrs. Nichols also recognized the Panorama Elementary 4 x 100 relay team. The girl's team ran the event knowing they would not be able to run as a qualified team in support of their team member who recently lost their mother to cancer and was unable to participate in the track meet. The three girls crossed the finish line, holding hands in encouragement of their team member and her family.

The Board of Education declared May 20-26, 2007 as *Classified School Employee Week* in the Orange Unified School District. Mrs. Nichols read the proclamation and presented it to Mr. John Miller, President of the California School Employees Association, Chapter 67.

The Board of Education recognized schools in the <u>Canyon High School Attendance Area</u> who have met one or more of the criteria in their work to improve student academic achievement as outlined in the Board agenda item.

The Board of Education recognized and congratulated the students, parents, faculty and staff of Canyon High School for being selected as a California Distinguished School for 2007.
