DESCRIPTION:

Information will be presented updating the Board and community on the progress of modernization projects throughout the District and the financing plan to continue the modernization program. The financing plan involves issuing OUSD 2008 Certificates of Participation (COP) to refinance approximately \$53 million of current COP debt from prior projects and issuing an additional \$42 million for the acquisition, construction, installation, and improvement of certain school facilities. The Certificates of Participation will be repaid using funds received through various Redevelopment agencies that can only be used for facilities projects.

This resolution will authorize execution of the documents necessary to complete this financing. These documents are on display in substantially final form in the Office of the Superintendent and the Business Services Office. The Official Statement was sent to the Board of Education on October 24, 2008.

FISCAL IMPACT:

Approximately \$42 million for school facilities projects.

RECOMMENDATION:

It is recommended that the Board of Education receive the facilities modernization report and approve Resolution No. 17-08-09: approving the form of and authorizing the execution and delivery of a Ground Lease, a Lease Agreement, an Assignment Agreement, a Trust Agreement, a Reimbursement Agreement, a Contract of Purchase, a Remarketing Agreement, a Continuing Disclosure Agreement and an Official Statement relating to a Lease Financing and approving certain actions in connection therewith.

RESOLUTION NO. 17-08-09

A RESOLUTION OF THE BOARD OF EDUCATION OF THE ORANGE UNIFIED SCHOOL DISTRICT APPROVING THE FORM OF AND AUTHORIZING THE EXECUTION AND DELIVERY OF A GROUND LEASE, A LEASE AGREEMENT, AN ASSIGNMENT AGREEMENT, A TRUST AGREEMENT, A REIMBURSEMENT AGREEMENT, A CONTRACT OF PURCHASE, A REMARKETING AGREEMENT, A CONTINUING DISCLOSURE AGREEMENT AND AN OFFICIAL STATEMENT RELATING TO A LEASE FINANCING AND APPROVING CERTAIN ACTIONS IN CONNECTION THEREWITH

WHEREAS, the Board of Education (the "Board of Education") of the Orange Unified School District (the "District") in order to, among other things, provide financing and refinancing for the acquisition, construction, installation and improvement of certain school facilities (the "Prior Project"), previously entered into a Sublease Agreement, dated as of February 1, 1994, and the Orange Schools Financing Corporation (the "Corporation") leased certain property back to the District under a Sub-Sublease Agreement, dated as of February 1, 1994, as amended by a First Amended and Restated Lease Agreement, dated as of May 1, 2003, each by and between the District and the Corporation (collectively, the "Prior Lease Agreement"); and

WHEREAS, the District desires to refinance the Prior Project by exercising its option to prepay the base rental payments to be made by the District pursuant to the Prior Lease Agreement; and

WHEREAS, the District desires to provide financing for the acquisition, construction, installation, improvement and equipping of certain schools and support facilities and land necessary for certain of such facilities (the "Project"); and

WHEREAS, in order to finance the Project and refinance the Prior Project, the District is leasing certain real property and the improvements thereto (the "Property") to the Corporation pursuant to a Ground Lease (the "Ground Lease"), and the District is subleasing the Property back from the Corporation pursuant to a Lease Agreement (the "Lease Agreement"); and

WHEREAS, in order to provide the funds necessary to finance the Project and refinance the Prior Project, the Corporation and the District desire to provide for the execution and delivery of Orange Unified School District 2008 Certificates of Participation (the "2008 Certificates"), with aggregate principal components not in excess of \$95,000,000, payable from the base rental payments (the "Base Rental Payments") to be made by the District pursuant to the Lease Agreement; and

WHEREAS, under the Lease Agreement, the District will be obligated to make rental payments to the Corporation; and

WHEREAS, it is proposed that certain rights of the Corporation under the Lease Agreement, including the right to receive Base Rental Payments, be assigned by the Corporation to a bank acting as trustee (the "Trustee") pursuant to an Assignment Agreement (the "Assignment Agreement"); and

WHEREAS, in consideration of such assignment and the execution of a Trust Agreement (the "Trust Agreement"), the Trustee will execute and deliver the 2008 Certificates in an amount equal to the aggregate principal components of such Base Rental Payments, each evidencing and representing a direct, fractional undivided proportionate interest in such Base Rental Payments; and

WHEREAS, in order to provide security for the 2008 Certificates and a source of payment for the purchase of 2008 Certificates tendered by the owners thereof when such purchase is permitted or required in accordance with the terms of the Trust Agreement, the District proposes to enter into a Reimbursement Agreement (the "Reimbursement Agreement") with U.S. Bank National Association (the "Bank") pursuant to which the Bank will issue a letter of credit; and

WHEREAS, Stone & Youngberg LLC (the "Underwriter") has submitted to the District a proposal to purchase the 2008 Certificates in the form of a Contract of Purchase (the "Contract of Purchase"); and

WHEREAS, in order to provide for the remarketing of 2008 Certificates tendered pursuant to the terms of the Trust Agreement, the District desires to enter into a Remarketing Agreement (the "Remarketing Agreement"); and

WHEREAS, the Board of Education proposes to provide for the disclosure of certain financial and operating data on an annual basis pursuant to the terms of a Continuing Disclosure Agreement (the "Continuing Disclosure Agreement"); and

WHEREAS, the Board of Education has full legal right, power and authority under the Constitution and laws of the State of California to enter into the transactions herein authorized; and

WHEREAS, the Board of Education has been presented with the form of each of the Ground Lease, the Lease Agreement, the Assignment Agreement, the Trust Agreement, the Reimbursement Agreement, the Contract of Purchase, the Remarketing Agreement, the Continuing Disclosure Agreement and the Official Statement and the Board of Education has examined and approved such documents and desires to authorize and direct the execution of such documents;

NOW, THEREFORE, THE BOARD OF EDUCATION DOES HEREBY RESOLVE, DETERMINE, FIND AND ORDER AS FOLLOWS:

SECTION 1. All of the Recitals herein contained are true and correct, and the Board of Education so finds.

SECTION 2. The Board of Education hereby finds and determines that it is in the public interest, convenience and welfare and for the common benefit of the inhabitants of the District that the District facilitate the financing of the Prior Project and the Project by authorizing the execution and delivery of the Ground Lease, the Lease Agreement, the Trust Agreement, the Reimbursement Agreement, the Contract of Purchase, the Remarketing Agreement, the Continuing Disclosure Agreement and the Official Statement and approving the Corporation's execution and delivery of the Assignment Agreement.

SECTION 3. The form and content of the Ground Lease (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and the District's (i) President, (ii) Vice President, (iii) Clerk, (iv) Superintendent, (v) Assistant Superintendent, Business Services, (vi) Assistant Superintendent, Administrative Services and (vii) such other officer or employee as the Superintendent may designate (each an "Authorized Officer"), and each of them acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Ground Lease in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer

executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes.

SECTION 4. The form and content of the Lease Agreement (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Lease Agreement in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes; provided, however, that the aggregate principal components of Base Rental Payments (as defined in the Lease Agreement) shall not exceed \$95,000,000; the Base Rental Payments shall be payable during a period of not more than 32 years (provided that such term may be extended as provided therein); the rate applicable to the interest components of the Base Rental Payments (or portions thereof) shall not exceed the applicable rates permitted under the Trust Agreement; and in the event the initial interest period is an Extended Rate Period (as defined in the Trust Agreement), the initial adjustment period shall not exceed 3 years, unless the term of the Letter of Credit is extended to a period equal to or greater than the term of such initial adjustment period, and the initial interest rate if the Certificates are executed and delivered in an Extended Rate Mode shall not exceed 4.25% per annum.

SECTION 5. The Board of Education hereby consents to the assignment by the Corporation of certain of its rights under the Lease Agreement, including the right to receive Base Rental Payments thereunder, to the Trustee for the benefit of the owners of the 2008 Certificates and approves the form of the Assignment Agreement (a copy of which is on file with the Secretary of the Board of Education), by and between the Corporation and the Trustee in substantially the form submitted to the Board of Education at this meeting.

SECTION 6. The form and content of the Trust Agreement (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Trust Agreement in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes. The execution and delivery by the Trustee, pursuant to the Trust Agreement, of the 2008 Certificates evidencing aggregate principal components not to exceed \$95,000,000, payable from Base Rental Payments during the period described above, is hereby approved. The 2008 Certificates shall be dated, shall be in the initial adjustable rate mode, shall have principal payment dates, shall be executed and delivered in the form, shall be subject to prepayment and shall be as otherwise provided in the Trust Agreement as the same shall be completed as provided in this Resolution. The proceeds of the sale of the 2008 Certificates shall be applied as provided in the Trust Agreement.

SECTION 7. Each Authorized Officer, acting singly, is authorized to engage the services of U.S. Bank National Association, as trustee, under the Trust Agreement.

SECTION 8. The form and content of the Reimbursement Agreement (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Reimbursement Agreement in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes.

SECTION 9. The form and content of the Contract of Purchase (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Contract of Purchase in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes; *provided*, *however*, that the underwriter's discount in connection with the execution and delivery of the 2008 Certificates shall not exceed 0.6% of the aggregate principal components evidenced by the 2008 Certificates.

SECTION 10. The form and content of the Remarketing Agreement (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Remarketing Agreement in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes.

SECTION 11. The form and content of the Continuing Disclosure Agreement (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Continuing Disclosure Agreement in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes.

SECTION 12. It is anticipated that the Certificates will initially be executed and delivered in either a Weekly Rate Mode or an Extended Rate Mode. If executed and delivered in a Weekly Rate Mode, an Official Statement will be utilized in connection with the sale of the Certificates and if executed and delivered in an Extended Rate Mode, a Preliminary Official Statement and an Official Statement will be utilized in connection with the sale of the Certificates. The form and content of the official statement (the "Official Statement") (a copy of which is on file with the Secretary of the Board of Education) submitted to the Board of Education at this meeting and incorporated herein as though set forth in full herein is hereby approved and the Board of Education hereby approves and authorizes the distribution of the Official Statement in substantially such form to prospective purchasers of the 2008 Certificates, with such additions and changes therein as an Authorized Officer may require or approve (including such changes as may be needed to reflect execution and delivery of the Certificates in an Extended Rate Mode and to cause such document to be initially prepared and

distributed in the form of a Preliminary Official Statement and thereafter to be prepared and distributed in the form of an Official Statement), such approval to be conclusively evidenced by the execution and delivery of the Official Statement, with such additions or changes (or in the case of the Preliminary Official Statement, by the execution and delivery of the certificate relating to the Preliminary Official Statement described below). If a Preliminary Official Statement is prepared, each Authorized Officer, acting singly, is hereby authorized and directed to certify on behalf of the District that such Preliminary Official Statement is deemed final as of its date, within the meaning of Rule 15c2-12 promulgated under the Securities Exchange Act of 1934 (except for the omission of certain final pricing, rating and related information as permitted by Rule 15c2-12). Each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the District, the Official Statement in substantially the form submitted to the Board of Education at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes.

SECTION 13. Each Authorized Officer, acting singly, is authorized and directed to enter into or execute such additional agreements, certificates or documents as are necessary to accomplish the execution and delivery of the 2008 Certificates. If any Certificates are executed and delivered in an initial Extended Rate Mode, each Authorized Officer, acting singly, is hereby authorized and directed, for and in the name of the District, to approve such changes to the documents referred to herein to reflect that such Certificates will be executed and delivered in an Extended Rate Mode. Each Authorized Officer, acting singly, is hereby authorized and directed, for and in the name of the District, to execute and deliver such other agreements (including irrevocable prepayment instructions and a termination agreement relating to the Prior Lease Agreement), certificates or documents in substantially said form as approved by an Authorized Officer with such changes therein as Special Counsel and District Counsel may require or approve, such requirement or approval to be conclusively evidenced by the execution of such other agreements by an Authorized Officer.

SECTION 14. All actions heretofore taken by any officer or employee of the District, with respect to the execution and delivery of the 2008 Certificates, or in connection with or related to any of the agreements referenced herein are hereby approved, confirmed and ratified.

SECTION 15. In order to consummate the lawful execution and delivery of the 2008 Certificates in accordance with this Resolution, each Authorized Officer, acting singly, is hereby authorized and directed, for and in the name and on behalf of the District to do any and all things and take any and all actions, which such Authorized Officer may deem necessary or advisable.

SECTION 16. This Resolution shall take effect immediately upon its adoption.

Homework/Make-up Work

Homework

The Board of Education believes that homework serves many important purposes. The administration and certificated staff shall design homework plans and assignments so that through their homework, students can reinforce academic skills taught in school and learn how to conduct research effectively, develop ideas creatively and become life-long learners.

The Board believes that homework is the responsibility of the student. It is the student's job to develop regular study habits and to do most assignments independently. The Board encourages teachers at all grade levels to use the parent/guardian as a contributing resource and to structure homework assignments so as to involve the parent/guardian without diminishing the student's sense of responsibility. When assigning homework which involves interaction with parents/guardians, teachers should include instructions which show how parents/guardians can best help their children.

To be effective, homework assignments should not place an undue burden on students and families. Homework should reinforce classroom learning objectives and be related to individual student needs and abilities. The Superintendent shall ensure that each school site develops an effective homework plan in accordance with Board policy and administrative regulation.

Make-up Work

Students who miss school work because of an excused absence shall be given the opportunity to complete all assignments and tests that can be reasonably provided. As determined by the teacher, the assignments and tests shall be reasonably equivalent, but not necessarily identical, to the assignments and tests missed during the absence. Students shall receive full credit for work satisfactorily completed within a reasonable period of time. (Education Code 48205) Teachers may require a suspended student to complete any assignments and tests missed during suspension. (E. C. 48913)

Students who miss school work because of unexcused absences shall be given the opportunity to make up missed work. Teachers shall assign such make-up work as necessary to ensure academic progress, not as a punitive measure.

FIRST QUARTER REPORT OF UNIFORM COMPLAINTS FOR THE WILLIAMS AND VALENZUELA CASE SETTLEMENTS

DESCRIPTION:

As a result of the State of California's settlement of the Williams and Valenzuela class action lawsuits, Education Code section 35186 requires school districts to do two things: 1) provide an opportunity to file formal complaints under the District's Uniform Complaint Procedures; and 2) report to the Board of Education and the public four times a year the number of complaints filed and the area of the settlement they target.

The First Quarter Report covers the number of Uniform Complaints received by the District under the four areas governed by the Williams and Valenzuela Case Settlements for the period of July – September 2008. The four targeted areas are:

- 1. Sufficient instructional materials
- 2. Emergency or urgent facilities conditions that pose a threat to the health and safety of pupils or staff
- 3. Teacher vacancy and misassignment
- 4. Pupils, including English Learners, who have not passed one or both parts of the high school exit examination by the end of the 12th grade are entitled to receive intensive instruction and services for up to two consecutive academic years after completion of the 12th grade, or until the pupil has passed both parts of the examination, whichever comes first.

No Uniform Complaints for any area have been reported during the first quarter for the Williams and Valenzuela Case Settlements.

WHEREAS, the Orange Schools Financing Corporation (the "Corporation") and the Orange Unified School District (the "District"), in order to, among other things, provide financing and refinancing for the acquisition, construction, installation and improvement of certain school facilities (the "Prior Project"), previously entered into a Sublease Agreement, dated as of February 1, 1994, and the Corporation leased certain property back to the District under a Sub-Sublease Agreement, dated as of February 1, 1994, as amended by a First Amended and Restated Lease Agreement, dated as of May 1, 2003, each by and between the District and the Corporation (collectively, the "Prior Lease Agreement"); and

WHEREAS, the District desires to refinance the Prior Project by exercising its option to prepay the base rental payments to be made by the District pursuant to the Prior Lease Agreement; and

WHEREAS, the District desires to provide financing for the acquisition, construction, installation, improvement and equipping of certain schools and support facilities and land necessary for certain of such facilities (the "Project"); and

WHEREAS, in order to finance the Project and refinance the Prior Project, the District is leasing certain real property and the improvements thereto (the "Property") to the Corporation pursuant to a Ground Lease (the "Ground Lease"), and the District is subleasing the Property back from the Corporation pursuant to a Lease Agreement (the "Lease Agreement"); and

WHEREAS, in order to provide the funds necessary to finance the Project and refinance the Prior Project, the Corporation and the District desire to provide for the execution and delivery of Orange Unified School District 2008 Certificates of Participation (the "2008 Certificates"), with aggregate principal components not in excess of \$95,000,000, payable from the base rental payments (the "Base Rental Payments") to be made by the District pursuant to the Lease Agreement; and

WHEREAS, under the Lease Agreement, the District will be obligated to make rental payments to the Corporation; and

WHEREAS, it is proposed that certain rights of the Corporation under the Lease Agreement, including the right to receive Base Rental Payments, be assigned by the Corporation to a bank acting as trustee (the "Trustee") pursuant to an Assignment Agreement (the "Assignment Agreement"); and

WHEREAS, in consideration of such assignment and the execution of a Trust Agreement (the "Trust Agreement"), the Trustee will execute and deliver the 2008 Certificates in an amount equal to the aggregate principal components of such Base Rental Payments, each evidencing and representing a direct, fractional undivided proportionate interest in such Base Rental Payments; and

WHEREAS, the Corporation has full legal right, power and authority under the Constitution and laws of the State of California to enter into the transactions herein authorized; and

WHEREAS, the Board of the Directors (the "Board") has been presented with the form of each of the Ground Lease, the Lease Agreement, the Assignment Agreement, and the Trust Agreement; and the Board has examined and approved such documents and desires to authorize and direct the execution of such documents;

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE ORANGE SCHOOLS FINANCING CORPORATION DOES HEREBY RESOLVE, DETERMINE, FIND AND ORDER AS FOLLOWS:

SECTION 1. All of the Recitals herein contained are true and correct and the Board so finds.

SECTION 2. The Board hereby finds and determines that it is in the public interest, convenience and welfare and for the common benefit of the inhabitants of the District that the Corporation facilitate the financing of the Prior Project and the Project by authorizing the execution and delivery of the Ground Lease, the Lease Agreement, the Assignment Agreement and the Trust Agreement.

SECTION 3. The form and content of the Ground Lease (a copy of which is on file with the Secretary) submitted to the Board at this meeting and incorporated herein as though set forth in full herein is hereby approved and the President, the Executive Director, the Treasurer and the Secretary (each an "Authorized Officer"), and each of them, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the Corporation, the Ground Lease in substantially the form submitted to the Board at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes.

SECTION 4. The form and content of the Lease Agreement (a copy of which is on file with the Secretary) submitted to the Board at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the Corporation, the Lease Agreement in substantially the form submitted to the Board at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes; provided, however, that the aggregate principal components of Base Rental Payments (as defined in the Lease Agreement) shall not exceed \$95,000,000; the Base Rental Payments shall be payable during a period of not more than 32 years (provided that such term may be extended as provided therein); and the rate applicable to the interest components of the Base Rental Payments (or portions thereof) shall not exceed the applicable rates permitted under the Trust Agreement.

SECTION 5. The form and content of the Assignment Agreement (a copy of which is on file with the Secretary) submitted to the Board at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the Corporation, the Assignment Agreement in substantially the form submitted to the Board at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes.

SECTION 6. The form and content of the Trust Agreement (a copy of which is on file with the Secretary) submitted to the Board at this meeting and incorporated herein as though set forth in full herein is hereby approved and each Authorized Officer, acting singly, is hereby authorized and directed to execute and deliver for and in the name and on behalf of the Corporation, the Trust Agreement in substantially the form submitted to the Board at this meeting, with such additions and changes therein as the Authorized Officer executing the same may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof with such additions or changes. The execution and delivery by the Trustee, pursuant to the Trust Agreement, of the 2008 Certificates evidencing aggregate principal components not to exceed \$95,000,000, payable from Base Rental Payments during the period described above, is hereby approved. The 2008 Certificates shall be dated, shall be in the initial adjustable rate mode, shall have principal payment dates, shall be executed and delivered in the form, shall be subject to prepayment and shall be as otherwise provided in the Trust Agreement as the same shall be completed as provided in this Resolution. The proceeds of the sale of the 2008 Certificates shall be applied as provided in the Trust Agreement.

SECTION 7. Each Authorized Officer, acting singly, is authorized to engage the services of U.S. Bank National Association, as trustee, under the Trust Agreement.

SECTION 8. Each Authorized Officer, acting singly, is authorized and directed to enter into or execute such additional agreements, certificates or documents as is necessary to accomplish the execution and delivery of the 2008 Certificates. If any Certificates are executed and delivered in an initial Extended Rate Mode, each Authorized Officer, acting singly, is hereby authorized and directed, for and in the name of the Corporation, to approve such changes to the documents referred to herein to reflect that such Certificates will be executed and delivered in an Extended Rate Mode. Each Authorized Officer, acting singly, is hereby authorized and directed, for and in the name of the Corporation, to execute and deliver such other agreements (including a termination agreement relating to the Prior Lease Agreement), certificates or documents in substantially said form as approved by an Authorized Officer with such changes therein as Special Counsel and Corporation Counsel may require or approve, such requirement or approval to be conclusively evidenced by the execution of such other agreements by an Authorized Officer.

SECTION 9. All actions heretofore taken by any officer or officers of the Corporation, with respect to the execution and delivery of the 2008 Certificates or in connection with or related to any of the agreements referenced herein, are hereby approved, confirmed and ratified.

SECTION 10. In order to consummate the lawful execution and delivery of the 2008 Certificates in accordance with this Resolution, each Authorized Officer, acting singly, is hereby authorized and directed, for and in the name and on behalf of the Corporation to do any and all things and take any and all actions, which such Authorized Officer, may deem necessary or advisable.

SECTION 11. This Resolution shall take effect immediately upon its adoption.
