## REPORT OF CLOSED SESSION DECISIONS AS REQUIRED BY THE BROWN ACT

**Dr. Godley** reported that the Board of Education took the following action: 1) Authorized the superintendent or designee to give notice of non-reelection to certain temporary employees pursuant to education code 44954(b) for the next succeeding school year. 2) The Board of Education authorized the release of a certificated administrator effective June 30, 2008. 3) The Board of Education is pleased to announce the appointment of Kristi Franco to the position of Coordinator II, Special Education effective for the 2008-09 school year.
