#### Superintendent's Report

Dr. Dreier recognized and extended congratulations to the following:

- Sue Brown, District school nurse, has been named recipient of the California School Nurses Organization's Nurse of the Year. This, in essence, means that Sue is the School Nurse of the Year for the entire State of California! Congratulations, Sue!
- Last week, Imperial Elementary teacher Marietta Jones and California Elementary teacher Daisy Chan received a welcomed surprise: an economic stimulus package for their classrooms a large box with \$1,000 worth of classroom supplies. One thousand teachers across the country were presented with the supplies as part of the "A Day Made Better" program sponsored by "Adopt-A-Classroom" and OfficeMax.
- This past Tuesday at Villa Park Elementary, teachers and principals met for a K-12 Professional
  Development training. The topic was Response to Intervention, which is a system of looking at all
  the interventions in the schools to make sure that all children are reached. Dr. Dreier was
  impressed with the quality of work and the dedication of staff and how engaged they were in the
  process.

Dr. Dreier announced that OUSD, along with many districts throughout southern California, participated in the Great Southern California Shake-Out, the largest earthquake preparedness activity in the United States. Dr. Dreier expressed her appreciation to Mike Pollok who coordinated this event and provided communication to all principals.

With sadness and great pride, Dr. Dreier announced that Dr. Marsha Brown, Assistant Superintendent of Educational Services, has accepted a position in the Antioch Unified School District, an area she was planning to move to. Dr. Dreier noted that it will be a great loss to the District and she will be missed, but that this is a terrific opportunity. Dr. Brown's expertise and dedication to the students has been remarkable. In her new position, Dr. Brown will be the Associate Superintendent of K-12 Educational Services, effective November 9<sup>th</sup>.

# Public Hearing on the Sufficiency of Textbooks, Instructional Materials and Science Lab Equipment (9-12) and Adoption of Board Resolution

The Williams Settlement set a specific timeline for districts in certifying the sufficiency of textbooks, instructional materials, and science lab equipment (9-12). The settlement requires a public hearing be held prior to the end of the eighth week after the first day pupils attend school. The Board held a public hearing and adopted Resolution No. 09-09-10 certifying to the California Department of Education that the District has complied with the requirement of Education Code Sections 60119(c) and 60422(b).
